Kildare County Council has prepared a Draft Local Area Plan for Leixlip for the 6 year period from 2017 to 2023. The new plan seeks to establish the planning context for future development in a manner that protects the existing character of the town whilst making it attractive to those who live, work, learn, visit or do business in Leixlip.

Any submission or observation should state your name address and, where relevant, the body or organisation represented. All submissions or observations with respect to the Draft Leixlip Local Area Plan 2017–2023 will form part of the statutory Chief Executive’s Report to be presented to the Elected Members of Kildare County Council. This report includes the names of those making the submissions or observations and will be included in the minutes of that meeting and subsequently published on our website. Children, or groups or associations representing the interests of children, are entitled to make submissions or observations to the proposed LAP.

The Draft Leixlip Local Area Plan 2017–2023 April 2017 is a revision of and supersedes the draft plan published in November 2016 and as such, submissions and observations made during the previous consultation period (November 2016 to January 2017) cannot be taken into consideration before the making of the Leixlip Local Area Plan. Members of the public and other interested parties are advised to make a new submission during the consultation period, if you wish to raise issues in relation to the revised Local Area Plan.
