



Public Consultations

The proposed redevelopment of the Wonderful Barn aims to restore the existing structures on the site, including one house, one barn (two dovecotes, a walled garden and two adjacent



courtyards containing two stable buildings (all protected structures - RPS no. B11-15). The proposed works will protect and enhance the architectural heritage and amenity of the site and provide an integrated public amenity park and tourism destination at the Wonderful Barn and associated lands, informed by a detailed conservation plan.
